Assessment of tenders will commence immediately and the Council has requested a report and recommendation be completed by 12 June 2008 for a Council meeting on 19 June 2008. A contingency Council meeting date in July is also scheduled in the event that evaluation or consideration of recommendations is not completed on 19 June 2008.

An evaluation panel comprising non-Councillor representatives from participating Councils of the TPRC has been appointed to conduct a formal evaluation of submissions. This panel will report to the Council in due course.

At this time the TPRC Council invites you to make a presentation to a special Council meeting on 15 May 2008 to talk to your submission, excluding matters relating to price. Presentations should not seek to change the essential requirements set out in the tender response.

All of the respondents to the tender invitation will be invited to make a presentation. Presentations should address the following:

- 1. Capability of the tenderer's practice and personnel;
- Approach and methodology to the project;
- Proposals for management of the project;
- 4. Community consultation for the project; and
- Time issues.

The Council has asked that submissions be limited to a period of 20 minutes followed by a 10 minute question period relating to items raised in the submission.

The tender evaluation panel has been invited, as observers, to the Council meeting but will not participate with questions or other exchanges.

The order of presentations by tenderers on 15 May 2008 will follow the order of acceptances to this invitation.
